To vote in an election in New York State, a person must be registered to vote (NY Const. Art II Â§ 5; Election Law Â§ 5-100). Registration with the County Board of Elections entitles a person to vote in all contests for public office that occur relating to the political jurisdictions wherein the person resides (NY Const. Art II Â§ 6).
